Honorable Board of County Commissioners,  
Tulsa County, Oklahoma.

Gentlemen:

The undersigned, being familiar with the Standard Specifications of the State of Oklahoma, respecting the construction of highways by bringing to profile grade etc., and being familiar with the location and character of the work to be done and performed in the grading of the hereinabove described highways, hereby proposes to furnish all labor, materials, and equipment and do the said work in each and every particular according to the stakes, cross sections, instructions and directions of the County Engineer or his duly authorized assistants, and to the complete and final acceptance of the County Engineer and your Honorable Board, at the prices hereinafter bid, which prices as hereinafter bid include all clearing and grubbing, the same being absorbed in the price bid per cubic yard. The prices bid are based on the approximate estimates of quantities which is made for estimating purposes only, payments to be made on the actual quantities moved, at the following unit prices, to-wit:

Force Account or Extra Work only when ordered in writing by the Engineer at actual cost plus 10% per cent.

NOTE: A new channel for Coal Creek is to be excavated between Stations 546 and 550 Bet. Secs. 10 & 11, T 17 R 12 (Mil 11, Sec. 21). The material from this channel is to be placed in the roadbed and paid for as Earth Borrow. Any surplus shall be placed in the old bed of creek where directed by the County Engineer and paid for as Earth Excavation.

Is awarded the contract, the undersigned agrees to begin the said work within 15 days after written authority to begin is given by the County Engineer, and at such point on the said work as ordered by the Engineer, and to complete all of the said work on or before the first day of April, 1928. The undersigned represents to your Board that he is experienced in such work and equipped to perform the said work, and if awarded the contract, will immediately enter into contract; furnishing satisfactory Surety Company Bond, both contract and statutory, in the full amount of One Hundred (100%) percent of the contract price. The undersigned further agrees to drag and blade each day the work as the same progresses, in order to keep the road open and free to travel, and to complete the same mile by mile as ordered. Upon failure to complete within the time specified, the County may deduct from any monies that may be due me the amount as named in the Oklahoma State Standard Specifications as liquidated damages for failure to complete within the time proposed.

When mutually agreed to by and between your Honorable Board and ourselves, this proposal may be considered for extension to additional work of the same character and upon the same highway and as a continuation of the work herein bid upon as though the same were herein originally contained and set out.

Certified Check (or Bidder's Bond) amounting to \$1,500.00 is hereto attached, being approximately 10% of the amount bid, based on the Engineer's approximate estimate of quantities and conforming to the specification provision and "Notice to Contractors".
