be necessary to ascertain the exact amount of money's coming in to the hands of said Lewis Cline, George E.Reeves, Roy Meacham, and any and all other persons who may have received any money's by reason of confiscation proceedings in Tulsa County, during the years 1917 and 1918 to which he or they were not entitled under the Laws of this State.

BE IT FURTHER RESCLVED. That upon the completion of said audit, by said Ed O.Cassidy that he transmit to the County Attorney of Tulsa County without further direction by the Board of Commissioners, and said County Attorney is hereby directed and requested to collest said several sums found to be due and owing by said several partiesand to institute any legal proceedings which may be necessary against said parties, and their official Bonds.
