## JUNE 3rd, 1912.

The Board of County Commissioners met in regular session in their rooms in the County Court House at 9:00 A.M., June 3rd, 1912. All members present.

The Board proceeded to audit claims against the County. (See claims)

Moved by Mr. North and seconded by Mr. Wooley, that petition and bond Bond of this date, signed by Township Board of Wekiwa Township be approved, and the following viewers appointed: J. Y. Brand; John Smiley and Harry Earns.

Description of Road: Beginning One Half Mile North of the Southeast corner of Section Ten (10), Township Nineteen (19) North, Range Eleven (11) East, and running West Sixty (60) feet wide, on the Half Section line through Section Ten (10) to the M. K. & T. R. R. Co's right of way; thence westward on the M. K. & T. R. R. Co's right of way and along the North side of said M. K. & T. R. R. Co's right of way to Wekiwa Station on M. K. & T. R. R.; the road to be in no place nearer than twenty-five (25) feet from the end of ties.

On motion, petition and bond of Township Board of Dawson Township, for Bond the following described road, was approved, and the following viewers appointed: Dawson E. L. Morgan, Frank Wolfe and John Polston. Twp

Description of Road: Beginning at the West end of Market Street at Depot Street; thence running west Sixty feet wide across Block No. 17 and Stone Quarry "C" and "D" Roadto East end of Market Street in the new part of Dawson, Okla. Thence running Block17 South from the west end of Market Street fifty feet wide to the St. Louis & San Francisco Rail Road Company's right of way; thence running southwest parall- Road Re'd el to the Frisco right of way; on the North side of fifty feet wide to the Section line between Sec. 28 and 33, Township 20, Range 13 East, Tulsa County, Page 112

## RESOLUTION.

It appearing that the Atchison, Topeka and Santa Fe Railway Company have paid all their taxes on all their property in Tulsa County for the year 1911 for state, county and municipal purposes, with the following exceptions: Supply Fund, \$224.29; Poor and Insance and Salary Fund, \$26.91; Owasso Township, all purposes, \$599.11; Dawson Township, general fund \$348.58; School District No. 22, \$38.21.

cit further appearing that the above named railway insists that the above taxes on its property are illegally levied, and therefore void.

And it further appearing that a conference at which the members of the board of County Commissioners were present, County Attorney for Tulsa County being present, and the representatives of the Railway Company also present, a compromise was reached whereby the said railway Company agreed to waive the illegality of a portion of the above taxes and levies, and make a further payment as follows:

Supply Fund \$224.29; Owasso Township, \$599.11; School District No.22, \$38.21; Dawson Township, general fund, \$174.29: still insisting on the illegality of levies as to the Poor and Insance and Salary Fund, \$26.91, and Dawson Township, general fund, \$174.29, offering therefore to pay \$1035.90, and asking that this Board remit as illegal and void and illegally levied and the taxes as above \$201.20.

Now, therefore, be it resolved, that the offere of the compromise made by the Railway Company be accepted and the taxes in Dawson Township for general purposes in the sum of \$174.29 be, and the same are hereby declared illegal, excessive and void, and are hereby remitted, and the County Treasurer of this County is authorized to accept payment of taxes for the Railway Company in such township taxes in the above sum taking credit therefor on this resolution; and that the taxes against said property of said Railway Company in this County on the poor and insance and salary fund in the sum of \$26.91 be declared illegal and excessive and void, and the same are hereby remitted, and the County Treasurer is authorized to accept this resolution as his authority for such non-payment and take credit for same hereon on his books.
