REPORT OF SURVEYOR TO COUNTY CLERK.

The undersigned, R. K. Hughes, the Civil Engineer heretofore appointed by the Board of County Commissioners of Tulsa County, Oklahoma, to receive bids, award contracts, and accept bonds for performance of work, on behalf of said Board of County Commissioners, in the matter of Drain No. 2, hereby submits his report of proceedings in regard thereto.

In pursuance of notice as required by law, on the 27th day of May, 1912, at 2 P. M., at the office of the County Commissioners of said County, and in the presence of said Board in open session, I opened bids submitted for the construction of said Drain, and after consideration of same, let contracts therefor to the lowest bidders, as follows, to-wit:

For the construction of Sections 1, 2 and 3 thereof to Rice and Dunn at the following respective prices: Section 1 - 18 cents per cubic yard; Section 2 - 22 cents per cubic yard; Section 3 - 20 cents per cubic yard.

For the construction of Sections 4 and 5 thereof to H. R. Ketchum at the following respective prices: Sec. 4, 11.8 cents per cubic yard; Section 5, 14 1/2 cents per cubic yard.

For the construction of 2 farm crossings and 1 road crossing in Section 2 thereof to John T. Reynolds at \$48.00 per crossing.

For the construction of one farm crossing in Section 3, one farm crossing in Section 4, and one road crossing in Section 5, thereof, to H. R. Ketchum at \$5.00 for each crossing and \$50.00 for the road crossing.

For the construction of one farm crossing in Section 1, and one farm crossing in Section 5, thereof, to Rice & Dunn, at \$52.50 per crossing.

Bonds as required by law have been filed for the faithful performance of work as awarded.

Said contracts and bonds are herewith presented for approval by the Board of County Commissioners.
