

for the purpose of erecting poles, or posts, on which are to be placed wires and/or conduits and other apparatus and equipment to be used for the purpose of transporting, transmitting and selling its electricity for light, heat and power.

IT IS FURTHER ORDERED that the installation and maintenance of said poles wires and other apparatus shall be under the instructions of the County Engineer of Tulsa County, Oklahoma, and same shall be placed in such manner as to least interfere with the public use of said highway and that said highway shall not be closed or obstructed and shall within a reasonable time be placed, as near as practicable, in as good condition of repair as same was prior to such construction, at the expense of said Sand Springs Home, and that in the event the Board of County Commissioners at any time decide to widen or change said highway, the sand Springs Home will, at its own expense, move its pole lines to conform to said change of width or location of said highway, and under the supervision of the County Engineer. The said Sand Springs Home agreeing at all time to hold Tulsa County harmless and free from any liability arising from any negligence or omissions of it in the construction and maintenance and operation of said poles, wires and apparatus.

In the matter of the application of the Sand Springs Home, a corporation, for consent to use the public road or highway through Section 6, Township 19 North, Range 11 East; also Sections 1, 2, 11, 10, 3, 4 and 6, Township 19 North, Range 10 East, for the erection thereon of poles, wires and fixtures for transmitting and transporting electricity for light heat and power.

O R D E R.

Now, On this 15th. day of June, 1925, the petition of the Sand Springs Home, a corporation, asking that consent be given for the use by the Sand Springs Home, of certain highways hereinafter described for the purpose of erecting and maintaining poles, wires and other apparatus and fixtures for the purpose of transmitting electricity for sale for light heat and power, coming on to be heard, and the Board being fully and sufficiently advised in the premises, finds:

That the applicant, Sand Springs Home, is a corporation chartered and existing under the laws of the State of Oklahoma, with its principal office at Sand Springs Oklahoma, and is authorized by its charter to transport transmit furnish and sell electricity for light, heat and power;

That it is necessary for it to use section lines and highways hereinafter described for said purposes and for furnishing electricity for light, heat and power to consumers and customers of said corporation.

IT IS THEREFORE ORDERED, By the Board of County Commissioners of Tulsa County Oklahoma, that the Sand Springs Home, a corporation be, and it is hereby authorized and empowered to use the public road and highway, situate in Tulsa County, State of Oklahoma, and described as follows, to-wit:

Beginning at a point on the south side of the public road on the east line of Section 6, Township 19 North, Range 11 East, Tulsa County, Oklahoma; follow thence south side of said highway in a westerly direction through section 6, thence south on the west
