only, that portion only of the Tulsa State Fair Grounds, at Tulsa, Tulsa, County, Oklahoma, consisting of the Grand Stand, Race Track, Race Horse Barns, Two new metal caitle barns and all grounds adjacent thereto. including the roadways leading to and from same, but not any part of such grounds heretofore leased to the International Petroleum Exposition from October 20th. to October 22d. 1927, both inclusive at \$300.00 a day, with the privilege, however, of renewal upon the same terms from October 25th. to October 29th both inclusive, with the privileges, however of renewal from October 1st. to November 5th. both inclusive, with the privilege of renewal from November 8th. to November 12th. both inclusive, with the privilege of renewal from November 15th. to November 19th. 1927, both inclusive, and for the rent and use of same for such purposes as said second party hereby promises and agrees to pay to furst party for each day so used, the sum of Three Hundred Dollars (\$300.00) same to be paid in advance for each interval of time embraced in the option, where the option to extend the race meeting from time to time is exercised bybsaid second part.

Said second party is hereby expressly granted the right and privilege, at his own cost and expense however, but under the direction and supervision of the Tulsa State Fair Board of Directors, to make any addall necessary changes, alterations, additiona and repairs on the grand stand, race track or adjacent grounds, to beautify, simplify and make more convenient, for the uses and purposes which said grounds are leased for.

And special privilege is granted second party, at his cost, but under the firection of the Fair Board, to build suitable stalls for horses in new cattle barns included herein to extend the roof framing now in place on the grand stand and roof all of same, to install sanitary ladies toilets beneath the grand stand; to erect suitable paddock and ticket booths to remove the present band stand, to whitewash or paint the fence ground the race track, and to paint the race horse barn, the jockey house, and to level the grounds inseide the race track, and to make such other improvements or changes as may be mutually agreed upon between the parties hereto.

It is further stipulated and agreed that the framing and roofing placed on the grand stand and the toilets places therein, are to be and remain in place as the property of the first party at the expiration of this lease contract, but said second party reserves the right to remove or cause to be removed, at his own expense, the ticket booths and paddocks within ten (10) days after the expiration of this lease, or now agrees toforfeit same to the first party.

Any other changes or alterations made shall be replaced to its present condition at the costs off the second party within ten (10) days after the termination of this lease, unless otherwise agreed between the parties hereto.

It is further stipulated and gareed between the parties that any failure on the part of the second party to comply with any of the terms and conditions of this lease, or to pay the rent of the premises as and when due shall operate as a forfeiture and termination of this contract, and the first party is hereby authorized to immediately and without notice take possession thereof and terminate this lease.

This contract shall enure to the benefit and be binding upon the successors and assigns of the parties hereto, provided, however, same shall not be transferred or assigned by said second party without the written consent of the first party endorsed in writing hereon.

Witness the hands of the respective parties hereto, and each party hereto acknowledge the receipt of a duplicate hereof, this the 13th. day of October, 1927.
