

C O N T R A C T.

This Contract made and entered into at Tulsa, Oklahoma, on this 16th day of August, 1920, by and between F. M. McFall owner and publisher of the Sand Springs Leader, a weekly newspaper of general circulation in Tulsa County, party of the first part, and the Board of County Commissioners of Tulsa County, Oklahoma, party of the second part.

WITNESSETH: that Whereas, the first party has this day submitted his bid in writing to the second party wherein said first party offers and agrees to prompt and publish all of the advertising and legal notices required of the Board of County Commissioners and Tulsa County, excepting delinquent tax notices, by law, at and for the flat rate of forty five (45¢) Cents per square, and delinquent tax at legal rate, and to give bond for the faithful performance of said contract, and, wherein, said second party has this day by resolution duly accepted said proposition, and authorized the making of this contract designating the said Sand Springs Leader as the official publication of Tulsa County.

NOW, THEREFORE, it is covenanted and agreed be and between the parties hereto that F. M. McFall, first party, shall maintain and keep the Sand Springs Leader, a legal publication, publishing each issue each week, throughout the life of this contract, and circulating each issue in and over Tulsa County, and shall do and perform all requirements required to make it a proper and legal medium for the advertising of any all all notices, minutes of meetings had, and all advertising required by law to be made by the County officials.

And the first party further contracts and agrees to publish all such matters as may be delivered to it by Tulsa County at the flat rate of Forty-five (45 ¢) cents per square of non-pariel type, the term flat rate being understood to mean and be forty five (45¢) cents per square per issue excepting delinquent tax notices, and they at legal rate.

And said first party further agrees and executes of even date herewith a bond in the sum of \$2000.00 Dollars, conditioned for the faithful performance of all of the terms of this contract.

The second party covenants and agrees with the first party to designate and make, and does hereby designate and make the Sand Springs Leader, a weekly newspaper of general circulation in and over Tulsa County, the official paper of said Tulsa County, for a period of one year from and after this date.

And said second party further covenants and agrees with first party to deliver to first party for publication in the Sand Springs Leader, all minutes, notices and legal publications required of it by law to be published officially for said one year.

Second party further covenants and agrees to pay for all such publication at the rate of forty five (45¢) cents per square of ten lines of nonpariel type for each weekly publication, and payment for said work to be made as all other claims against the county.

R E S O L U T I O N.

The following resolution was offered, voted upon, and passed:-

Whereas, I, Thomas I. Munroe, County Attorney, has heretofore nominated and designated among others, as deputies, to wit: S. E. Dunn, A. E. Montgomery, Saide Hoffman and Zella Lawrence, and

Whereas his designation and appointment of these deputies heretofore was confirmed and salaries therefor fixed has been and by and with the consent of the Board of County Commissioners; and

Whereas, Chapter 187 of the acts of the 7th legislature approved March 24th, 1919, provides that the Board of County Commissioners is given the power and authority to fix compensations of such deputies.

BE IT THEREFORE resolved that the compensation of said deputies be fixed as follows: S. E. Dunn, \$200.00 per month, A. E. Montgomery, \$200.00 per month, Saide Hoffman, \$165.00 per month, and Zella Lawrence, \$150.00 per month.

And be it further resolved that this compensation be fixed and determined beginning from the first day of July, 1920.
