PETITION OF THE SAND SPRINGS RAILWAY COMPANY, A COPPORATION, FOR A GRANT OF THE RIGHT TO USE AND OCCUPY SECOND STREET OF TWIN CITIES FOR RAILROAD PURPOSES.
