R E S O L U T I O N

NOW, THEREFORE, BE IT RESOLVED, that the County Engineer be, and he is hereby authorized and directed to secure prices and enter into informal contract for the grading of Mile Four (4) Section "YY" Tulsa County Highway.

R E S O L U T I O N .

AND, WHEREAS, it is deemed to be to the best interest of Tulsa Co,unty that a certain County Highway be designated.

NOW, THEREFORE, BE IT RESOLVED, that a highway

Beginning at the west end of the present Tulsa-Osage County Line Highway as designated by this Board on October 15,1928, thence in a westerly direction thru Sec. 6, T 19 N., R 12 E., near the north end of said Section, according to the County Engineer's survey and plat thereof

be designated as a part of the County Highway System, same to be known as Mile 4 of Section "YY".
