

At a meeting of the Board of County Commissioners of Tulsa County, State of Oklahoma, on the 29th. day of January, 1923, the following resolution was introduced by Ira Short, Member of the Board, who moved its adoption. The motion was seconded by Geo.E.Gilmore, Chairman of the Board, and upon roll call the same was declared carried.

R E S O L U T I O N.

BE IT RESOLVED, By the Board of County Commissioners of Tulsa County, that there be created as a State Highway and added to the present State Highway System in Tulsa County, the following described road:-

"Beginning at the corner's of Sections 26 - 27 - 34 and 35, Township 18 North, Range 14 East, and running thence South Two (2) Miles to the corner of the Sections 2-3-10 and 11 of Township 17 North North, Range 14 East; thence West along the line between Sections 3 and 10, 4 and 9, 5 and 8, 6 and 7, to an intersection with the Tulsa-Bixby State Highway".

The same to be designated as Section "Q1" and numbered as Miles 1 to 6 inclusive; such mileage designation beginning with Mile 1 as the line between Sections 34 and 35, Township 18 North, Range 14 East, and Mile 6 being the line between Sections 6 and 7, in Township 17 North, Range 14 East.

WHEREAS, by reason of the necessity that the above road be so designated in order that the same may be improved in the interest of the proper development, and

WHEREAS, the same being located in WILLOW SPRINGS TOWNSHIP of this County, which Township has not had the benefits accruing to said Township from State road locations therein, and

WHEREAS, Tulsa County by designating the same as a State Highway does not increase the State Road Mileage above the 15% as provided by law.

NOW, THEREFORE, In consideration of the above, it is the sense of this Board that said above described road be declared a State Highway, and that copies of the same be forwarded the Commissioner of Highways for his approval.
