GENERAL RELEASE

KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of One Dollar (\$1.00), cash in hand paid, the receipt and sufficiency of which are hereby acknowledged, the Board of County Commissioners of Tulsa County, Oklahoma, has released, and by these presents does hereby remise, release and forever discharge the United State of America of and from all claims, demands, actions and causes of action of every kind and character whatsoever, whether at law or inequity, as against the United State of America said County of Tulsa ever had, nor has or might have reason to claim by reason of, arising out of, or in anywise connected with, the action of said County of May 3, 1943, enclosing a certain highway through the southeast Quarter (SE $\frac{1}{4}$) of Section 13, Township 20 North, Range 13 East and the construction of a substitute or replacement highway by the United States of American through parts of the South Half (S $\frac{1}{2}$) of said Section 13, Township 20 North, Range 13 East, Tulsa County, Oklahoma, including all claims for damages, for maintenance, for restoration or for any other circumstance or transaction, things done or not done by the said United State of America in connection therewith.
