## RESOLUTION

WHEREAS a new law has been passed by the State Legislature and signed into law by the Governor of the State of Oklahoma allowing each county in Oklahoma to vote on whether to approve the sale of alcoholic beverages by the individual drink for on-premises consumption; and,

WHEREAS the Board of Coummissioners of each county may, on its own motion, call a Special Election to vote on such a measure; and,

WHEREAS the residents of Tulsa County have previously voted in favor of the sale of alcoholic beverages by the individual drink for on-premises consumption when the question was presented on the statewide ballot; and,

WHEREAS the residents of Tulsa County should be allowed to vote on whether to approve the sale of alcoholic beverages by the individual drink for on-premises consumption in Tulsa County at the earliest possible date; and,

WHEREAS a Special Election has already been called on April 30, 1985 to consider a State Question; and,

WHEREAS it is possible to add to that Election the question of whether the residents of Tulsa County approve the sale of alcoholic beverages by the individual drink for on-premises consumption;

BE IT THEREFORE RESOLVED that the Board of Commissioners of Tulsa County, State of Oklahoma, does hereby call a Special Election on April 30, 1985 for the purpose of placing before the people of Tulsa County the question of the approval of the sale of alcoholic beverages by the individual drink for onpremises consumption; and further,

BE IT THEREFORE RESOLVED that the Board of Commissioners of Tulsa County does hereby approve the following language for the ballot proposition for the Special Election for April 30, 1985:
