COUNTY COMMISSIONER:-

Gentlemen:

This is to inform you that the road is impassable at the foot of the same hill near spring between Sec. 20, and 29, Fry Township. I do not think any thing will do here except a bridge or dip, also, a bridge is needed between Sec. 35 - 26 near Kramers Corner. Please give this your prompt attention as I cannot pass over places mentioned with the mail.

The first mentioned place will doubtlessly require in the caring for the same, a bridge approximately 20 feet in length, and at the latter place a bridge or culvert of about 10 foot span. An emergency exists at both places on account of the same being a mail route, and the Township is unable to make the improvements.
