TUESDAY, AUGUST 3rd, 1937.

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 11:00 o'clock A.M., with all members present: John H. Miller, Chairman; J. B. Gray and Harry L. Hopkins, members. Andy Stokes, County Clerk.

Chairman Miller presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that the following amounts be allocated to the following for Drugs and Supplies for the month of August, 1937: Red Fork \$30.00; Sperry \$25.00; Skiatook \$10.00; Dr. Smith \$50.00; Sand Springs \$25.00; Collinsville \$50.00; Bixby \$50.00; Broken Arrow \$50.00; Jenks \$25.00; Dr. Motley \$75.00; Dr. Barham \$150.00; Dr. Roberts \$50.00; Dr. McGuire \$5.00; Dr. Roberts, for the jail \$100.00; Clinic \$100.00; Wm. Penn Drug store \$400.00, to be divided as follows: Dr. Roberts \$100.00; Dr. McGuire \$25.00; Dr. Motley \$50.00 and Dr. Barham \$225.00. Also Dr. Childs \$60.00 and Dr. Hairston \$40.00. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Hopkins, seconded by Commissioner Miller, that the County Farm be allocated \$225.00 per month for drugs for the month of August, 1937. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that the following Hospitals be allocated the following amounts for the month of August, 1937: Morningside Hospital \$1,750; Sisler \$900; St. Johns \$100; St. Mary's Hospital \$100; Poole Hospital \$50; and Flower Hospital \$100. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that the Welfare Department be instructed to write orders for groceries not to exceed \$2,000.00 for the month of August, 1937. Upon roll call, the following vote was taken: Miller, yes; Hopkins, yes; Gray, yes. Motion carried.

WHEREUPON, at the hour of 12:00 o'clock Noon, a recess is hereby taken until Wednesday, August 4th, 1937, at the hour of 10:00 o'clock A.M.
