MONDAY, OCTOBER 5th, 1942.

The Board of County Commissioners met in regular session on Monday, October 5th, 1942, at the hour of 10:00 o'clock A.M., with all members present: J. B. Gray, Chairman; Ralsa F. Morley and Curtis Greer, members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion by Commissioner Morley, seconded by Commissioner Greer, that the following resolution be adopted. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

R E S O L U T I O N

WHEREAS, on the 14th day of September, 1942, there was presented to this Commission an application to vacate a certain portion of a certain street or streets in Wilshire Manor, an addition to the City of Tulsa, Oklahoma, more specifically described as follows, to-wit:

Beginning at the southeast corner of Lot 4, Block 5, Wilshire Manor, an addition to the City of Tulsa, Oklahoma, thence westerly along the southerly line of said Lot 4, a distance of 115 feet to a point; thence in a northwesterly direction, around a curve whose radius is 25 feet, a distance of 39.27 feet to a point, said point being 40 feet southerly from the northwest corner of said Lot 4 and on the westerly line of said Lot 4; thence southerly and on a straight line, distance of 100 feet to a point on the westerly line of Lot 1, Block 7 of said addition and 40 feet northerly of the southwest corner of said Lot 1; thence in a northeasterly direction, around a curve whose radius is 25 feet a distance of 39.27 feet to a point; thence easterly along the northerly line of said Lot 1, a distance of 115 feet to a point, said point being the northeasterly corner of said Lot 1; thence northerly and on a straight line, a distance of 50 feet to the point of beginning, all in Wilshire Manor, an addition to the City of Tulsa, Oklahoma, according to the recorded plat thereof,

which said application was duly and properly signed by twelve freeholders residing in the vicinity of said street or streets so to be vacated.

THEREUPON an order was made directing notice to be given for twenty days in the Tulsa Daily Legal News, a newspaper printed and published in Tulsa County, Oklahoma, and bond was likewise directed to be given covering costs of these proceedings, and

WHEREAS, said notice has been duly published, as shown by the affidavit of the printer of the said Tulsa Daily Legal News, on file herein, and said bond has likewise been given and approved, and

WHEREAS, no objections having been filed and no person being present objecting to the proposed vacating of said portion of said street or streets,

THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, that that portion of street or streets above specifically described be and the same is hereby vacated and that the land and real property on which said portion of said street or streets was located be and remain from and after this date the same as if said portion of said street or streets had never been laid out, dedicated or existed.
