Young reviewed the proposed Resolution and Election Proclamation, noting that there will be two (2) Propositions on the ballot, two (2) Polling Places (#1 - Glenpool City Hall and #2 Duck Creek Church), and the election would be held on February 22, 1983. Young also noted a resolution passed by the Glenpool City Council in which the City of Glenpool stated it would assume all costs of the proposed election.

Motion made by Rice, seconded by Young, to approve and authorize execution by Commission of the following resolution:

## RESOLUTION

A RESOLUTION AUTHORIZING THE CALLING AND HOLDING OF AN ELECTION IN TULSA COUNTY, OKLAHOMA, FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED VOTERS OF SAID COUNTY THE QUESTION OF THE CREATION OF AN EMERGENCY MEDICAL SERVICE DISTRICT, THE QUESTION OF LEVYING A SPECIAL THREE (3) MILL ANNUAL TAX FOR SUPPORT, ORGANIZATION AND MAINTENANCE OF DISTRICT AMBULANCE SERVICES, AND THE QUESTION OF THE ISSUANCE OF BONDS OF SAID DISTRICT IN THE SUM OF SIXTY FIVE THOUSAND (\$65,000.00) DOLLARS TO PROVIDE FUNDS FOR THE PURPOSE OF ACQUIRING EMERGENCY VEHICLES AND OTHER EQUIPMENT AND MAINTAINING AND HOUSING SAME, LEVYING SPECIAL ANNUAL TAXES THEREFOR, AND FIXING MATURITIES OF BONDS.

WHEREAS, it has been determined that the area embracing Independent School District No. 13 of Tulsa County, Oklahoma, is in need of additional ambulance services; and

WHEREAS, it is deemed advisable by Tulsa County to create a Glenpool Area Medical Service District to meet this need; and

WHEREAS, it has been determined that such District should embrace all of the area encompassed by the boundaries of Independent School District No. 13 of Tulsa County, Oklahoma; and

WHEREAS, additional money will be needed to fund the acquisition of ambulances, equipment and the housing of same and to fund the support organization, and operation and maintenance of ambulance services; and

WHEREAS, there are no funds available in the treasury for such purposes and power is granted said County by Section 9C, Article X of the Constitution and laws of the State of Oklahoma, to create an Emergency Medical Service District and provide funds for the purposes hereinabove set out, provided the same be authorized by the qualified voters of said District voting at an election held for such purposes; and

WHEREAS, the City of Glenpool, Oklahoma, has agreed by resolution to pay all costs incurred in the authorizing, calling, holding and conducting of the above referenced election.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF TULSA, STATE OF OKLAHOMA:

SECTION 1. That the Chairman of said Board of County Commissioners be and he is hereby authorized and directed to call a special election to be held in the area of said County embracing Independent School District No. 13 of Tulsa County, Oklahoma, on the 22nd day of February, 1983, for the purpose of submitting to the qualified voters thereof the following Propositions:

## PROPOSITION NO. 1

SHALL AN EMERGENCY MEDICAL SERVICE DISTRICT BE FORMED EMBRACING THE AREA CONTAINED IN INDEPENDENT SCHOOL DISTRICT NO. 13 OF TULSA COUNTY, OKLAHOMA, FOR THE PURPOSE OF PROVIDING AMBULANCE SERVICES FOR SAID DISTRICT AND SHALL A SPECIAL ANNUAL RECURRING AD VALOREM TAX LEVY OF THREE (3) MILLS ON THE DOLLAR OF THE ASSESSED VALUATION OF ALL TAXABLE PROPERTY IN THE DISTRICT BE LEVIED TO PROVIDE FUNDS FOR THE PURPOSE OF SUPPORT, ORGANIZATION, OPERATION AND MAINTENANCE OF DISTRICT AMBULANCE SERVICES?

## PROPOSITION NO. 2

SHALL THE GLENPOOL AREA MEDICAL SERVICE DISTRICT INCUR IN INDEBTEDNESS BY ISSUING ITS BONDS IN THE SUM OF SIXTY FIVE THOUSAND (\$65,000.00) DOLLARS TO PROVIDE FUNDS FOR THE PURPOSE OF ACQUIRING EMERGENCY VEHICLES AND OTHER EQUIPMENT AND MAINTAINING AND HOUSING SAME, AND LEVY AND COLLECT A SPECIAL TAX, PAYABLE ANNUALLY, IN ADDITION TO ALL OTHER TAXES, UPON ALL THE REAL AND PERSONAL TAXABLE PROPERTY IN SAID DISTRICT AS IT FALLS DUE, AND ALSO TO CONSTITUTE A SINKING FUND FOR THE PAYMENT OF THE PRINCIPAL THEREOF WHEN DUE, SAID BONDS TO BEAR INTEREST NOT TO EXCEED THE RATE OF TEN PER CENTUM (10%) PER ANNUM, PAYABLE SEMI-ANNUALLY AND TO BE SERIAL BONDS, MATURING ANNUALLY AFTER THREE (3) YEARS FROM DATE OF ISSUE, AND FOR A PERIOD WITHIN THIRTY (30) YEARS FROM THEIR DATE: PROVIDED, HOWEVER, THAT IN NO EVENT SHALL THE REAL AND PERSONAL TAXABLE PROPERTY IN SAID DISTRICT BE SUBJECT TO A SPECIAL TAX IN EXCESS OF THREE (3) MILLS ON THE DOLLAR FOR ALL BONDS ISSUED UNDER SECTION 9C, ARTICLE X OF THE OKLAHOMA CONSTITUTION?
