line for the transportation of natural gas along, upon and under certain streets in

Addition, and Industrial Heights Addition, all being additions to the City of Collinsville, Oklahoma, the location of said pipe line to be as follows, to-wit:

Beginning at the south line of Commercial Addition on South Nineteenth (S 19th) Street, at the City Limits, running northerly on said south Nineteenth Street to the intersection of said South Nineteenth Street and that portion of High Street running through Morrow Heights Addition, thence westerly upon and along said High Street in Morrow Heights Addition to the intersection of High Street and South Twenty First (S 21st.) Street in said Morrow Heights Addition, and also from the intersection of Laclede Street and South Nineteenth Street in a Westerly direction to the intersection of said Laclede Street and South Twenty Fifth (S25th) Street in Industrial Heights Addition

those portions of said pipe line running north and south being of approximately five or six inch line pipe and those portions running east and west being of approximately three inch line pipe. Said line to be laid, maintained and removed under and in accordance with the specifications and requirements of the County Engineer of Tulsa County, Oklahoma, and said Company in all things in connection with the laying, erect ing, maintaining and removing of said pipe line to comply with the requirements and specificiations of the County Engineer in connection therewith.
