The Board of County Commissioners met in called meeting at 10 o'clock A.M. in their rooms in the Tulsa County Court House, November 23, 1916. Present Cyrus S. Avery, Chairman of the Board, A.W. Lucas, and Ed. Baker, members.

The following resignation of John R. Ramsey, County was presented to the Board.

TO THE BOARD OF COMMISSIONERS OF TULSA COUNTY, OKLAHOMA.

Gentlemen:-

I, herewith, tender my resignation as County Judge for Tulsa County, Oklahoma, to become effective immediately

While taking this action I desire to express to you my appreciation of the uniform courtsey which has at all times been extended to me by your honorable board.

In explanation of my resignation I desire to say that a few days after the recent election I received an offer of a position in the legal department of The Texas Company which I deemed it to my personal advantage to accept.

The above resignation was read aloud by Cyrus S. Avery, Chairman. Motion was made by Cyrus S. Avery, and seconded by A.W. Lucas, that the resignation be accepted.

The Board adjourned for private consultation. Upon return of the Board of Commissioners it was moved that H.L. Standeven be appointed to fill the vacancy of County Judge caused by the resignation of Judge Ramsey. Motion Carried.
