R E S O L U T I O N

WHEREAS, There comes before the Board the petition of the WOODLAND PARK DEVELOPMENT COMPANY to vacate portions of the County Road right of way between Sections 13-14, and 23-24, T 20 N., R 13 E., Tulsa County Oklahoma, being a strip Thirty Three (33') feet wide 16.5 feet on each side of the Section line, the same being the legal road right of way between Sections 23 & 24, T 20 N., R 13 E., Tulsa County Oklahoma, extending 1319.7 feet south from the north lines of said Sections 23 & 24; to a one-sixteenth section corner. And, also, a similar strip between Sections 13 & 14, T 20 N., R 13 E., extending 3533.3 feet North from the south lines of said Sections 13 & 14, total distance, vacation of which is requested, being 4853.0 feet, except a strip 33 feet wide and 70 feet long which is a portion of the right of way of the east and west road between Sections 14 and 23, and between Sections 14 and 23, and between Sections 13 and 24.
