Roy Evans, Chairman, presiding, the following business was transacted:

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that the Bond of Otha Wolf, former Justice of the Peace, in the amount of \$1,000.00, issued by the National Surety Company, be and the same is hereby cancelled.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the County Clerk be, and he is hereby instructed to prepare a financial statement, as of the close of March, 1948, for the purpose of making a supplementary appropriation.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that statement be given to the State Engineer, Farm-to-Market Roads, designating Mr. George O. Straughan, Tulsa County Engineer as Engineer on our Farm-to-Market projects, and that the Engineering on said projects will be paid from County funds.

Motion made by Commissioner Evans, seconded by Commissioner Bailey, and unanimously carried, that the following claims be, and the same are hereby approved for payment, and the County Clerk is hereby authorized to issue warrants covering same:
