is requested, contains 3.62 acres, more or less.

AND, WHEREAS, no portion of the Section line road, the vacation of which is requested, has been used as a road for the past seven or eight years.

AND, WHEREAS, there are no parties living at anh point who will be affected by the closeing of this Section line road; all abutting property on each side of this road being owned by the Woodland Park Development Company, of which Cyrus S Avery is Secretary and Treasurer and C H Terwilleger is President.

AND, WHEREAS, there is submitted to the Board herewith an instrument duly signed and attested, dedicating to public highway uses forever a strip of land eighty (50') feet wide, the north and south ends of which are identical with the north and south endd of the strip sought to be vacated. This strip, 5139 feet long, 2869 feet of which are paved, is now used as a road, replacing the old road on the Section line sought to be vacated.

NOW, THEREFORE, BE IT RESOLVED, That this Petition be granted and that the portions of the County Road right ofway between Sections 13 and 14, and 23 and 24, T 20 N., R 13 E. Tulsa County Oklahoma, as described above, are hereby vacated.

TO THE HONORABLE BOARD OF COUNTY COMMISSIONERS, TULSA COUNTY, OKLAHOMA.

The undersigned, Evelyn Short, as Administratrix of the Estate of Posey R Short, Deceased, represents and states that as such Administratrix she has charge of certain gas wells and distributing lines owned by the said Deceased, at the time of his death, and that she is conducting the business which the said Posey R Short was conducting at the time of his death, under an order of the County Court of Tulsa County, Oklahoma.

That the business of said estate consists in the operating of various wells producing natural gas and the distribution and sale of same to various consumers in Tulsa County. That the present time the estate owns a gas distributing line connected with certain of its wells, running along and near the Bank of the Arkansas River, to a point directly East of Twenty First Street in West Tulsa, Oklahoma; that continuing eastward from the City Limits said Twenty First Street is produced to the bank of the said Arkansas River by a certain opened section line roadway. That at the present time your Petitioner has an opportunity to sell gas to the Alridge Linen and Towel Supply, at 2131 South Quannah Avenue West Tulsa, and that in order to effect delivery thereof it will be necessary that she lay a 3" gas line along the south side of roadway from the point nearest the bank of the Arkansas River now reached by her system of gas lines to the City limits of West Tulsa.

Your Petitioner represents and says that is she is granted a permit to lay said line along said roadway the same will be buried and laid in such a manner as to not interfere with the traffic, and that all of the rules and regulations imposed by the County Commissioners of Tulsa County will be complied with.

WHEREFORE, Your Petitioner prays that she be granted a permit to lay said gas line along said roadway for the purposes aforesaid.

In the matter of laying a Water Pipe line under andalong acertain highways, the following order was made:

ORDER

NOW, On this the 19th, day of September, 1932, the matter of the Petition of Dennision and Clark for permission to lay a water pipe line under and along certain high ways in said County and State came up before the Board of County C mmissioners of said County for hearing, and it appearing to the Board and each of the Commissioners thereof, that it was just that the said Dennison and Clark be permitted to use as much of the high ways as designated by blue print filed by said Company, and according to said description which is as follows, to-wit:

Beginning at a point on the North side of 41st.Street, approximately 2527 feet East of Peoria Ave (Point marked by City fire hydrant) and extending West along the North side of 41st.Street right of way for a distance of 1706 feet, thence, under and across said 41st.Street and South for a distance of 338 feet, extending to and across 41st.Place to the South side of the 41st.Place right of way, thence West for a distance of 771 feet. At a point approximately 106 feet East of the West end of the 41st.Place line, an additional extension shall extend South across private right of way for a distance of approximately 615 feet, crossing 42d.Street at a point approximately 150 feet East of Peoria Avenue; a,proposed 2 inch water line located according to blue print hereto attached and made a part hereof, together with approximately nine (9) 3/4 inch service lines crossing 41st.Place at an approximate distance of every 75 feet.

AND, it further appearing from the Petition herein that said water pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways; and will be constructed in accordance with all rules of the County Commissiners and the Laws of the State of Oklahoma governing same.
