### RESOLUTION

WHEREAS, the County Treasurer has on deposit \$773.64, credited to a special County Farm Insurance account, being insurance moneys received by the County Treasurer in payment of fire losses at the County Farm; and

WHEREAS, the County Treasurer has on deposit \$90.25, credited to a special County Insurance Account, being insurance moneys received by the County Treasurer in payment of fire losses to county property; and

WHEREAS, the County Treasurer has on deposit \$250.00, credited to a special Ball Park Insurance Account, being insurance moneys received by the County Treasurer in payment of fire losses to county property at the Ball Park; and

WHEREAS, the County Treasurer has on deposit \$1,661.76, credited to a special Fair Grounds Insurance Account, being insurance moneys received by the County Treasurer in payment of fire losses to county property at the Fair Grounds; and

WHEREAS, said moneys are not needed to rebuild, repair or replace the property so damaged or destroyed.

NOW, THEREFORE, BE IT RESOLVED that by reason of the provisions of Title 19, Section 627 O. S. 1941., the said sums of \$773.64, \$90.25, \$250.00, and \$1,661.76, credited as aforesaid, be, and the same are each hereby declared to be income from sources other than ad valorem taxes, not needed to rebuild, repair or replace the properties so damaged or destroyed by fire, and that said sums, and each of them, be credited to the General Fund of the county as provided by law, and that the County Treasurer be advised hereof.
