NOW, THEREFORE, BE IT RESOLVED, That the County Engineer be, and he is hereby directed and authorized to prepare plans and specifications and to advertise for bids for bring ing to profile grade the east portion of Section line between Sections Twenty Five (25) and Thirty Six (36), Township Twenty One (21) North, Range Thirteen (13) East.

Passed and approved by this Board on this 16th. day of June, 1930, with the specific understanding that work order will not be issued on the above outlined work until the tax protest suits now pending in the Supreme Court of the State of Oklahoma are settled in favor of Tulsa County, and funds thus released are available for the payment of said work.

All members of the Commission voting in favor of the above Resolution, same were unanimously adopted.

MEMORANDUM OF AGREEMENT FOR EXTENSION WORK.
Between

TULSA COUNTY

and the

EXTENSION DIVISION OF THE OKLAHOMA AGRICULTURAL AND MECHANICAL COLLEGE
Co-Operating with
THE UNITED STATES DEPARTMENT OF AGRICULTURE.

OBJECT:

For the purpose of assisting farmers and farm families of Tulsa County with the many problems of farming, home making and community life, the Extension Division of the Oklahoma Agricultural and Mechanical College and the Board of County Commissioners of said County acting under authority of law, enter into this contract for carrying on co-operative demonstration work in agriculture and home economics, including 4-H Club work, in Tulsa County during the year beginning July 1, 1930 and ending June 30th. 1931.

METHOD OF PROCEDURE

For the objects expressed above, the Oklahoma Agricultrual and Mechanical College, cooperating with the United States Department of Agriculture, shall select the agent or agents to be employed, such personsto be well qualified to fill these positions by training, education and experience, who shall be satisfactory to the Commissioners of said County.

COUNTY FUNDS AND EQUIPMENT. The County Commissioners agree to pay Two Hundred Twenty Five Dollars \$225.00) per month on the salary of a County Agricultural Agent and One Hundred Twenty Dollars (\$120.00) per month on the salary of ma County Home Demonstrator Agent for a period mof Twelve (12) months beginning July 1, 1930. The County Commissioners further agree to furnish an office and to appropriate the following amounts to apply on the expenses of the County Agent \$2200.00; for the County Home Demonstrator Agent \$1,000.00; for Office Assistant to County Agent \$1,920.00; the expenses to be paid monthly and the total amount paid in one month not to exceed the proportionate part of the year the agent has worked.

COLLEGE FUNDS AND. EQUIPMENT. In addition to the funds furnished by the County, the Extension Division of the Oklahoma Agricultural and Mechanical College, cooperating with the United States Department of Agriculture, will pay one Hundred Ten Dollars (\$110.00) per month on the salary of the County Agricultural Agent, and will pay One Hundred Ten Dollars (\$110.00) per month on the salary of the Home Demonstration Agent. The Extension Division of the A & M College also agrees to furnish all agents employed with the franking privilege for the free use of the mails in sending of agricultural publications in the County, to furnish the agents necessary stationery, instructions and printed bulleting for the use of farmers in the County, both from the college and the United States Department of Agriculture.

SUPERVISION.

The Extension Division of the Oklahoma Agricultural and Mechanical College will supervise the work of these agents, carefully looking after the same to see that the work is done efficiently and in ammanner to be of the largest possible benefit to the people of the county, and to pay the expenses of the agents when they are authorized to attend meetings outside of the County on official business.

SPECIAL AID.

The said A & M College likewise agrees to send to the county special representatives to assist these agents on special tasks, and to hold educational meetings for the benefit of farmers and to assist in every possible way in making the work in the County effective.

PAYMENT OF SALARY.

In case of any dissatisfaction with the work of the agent, on the part of the A & M College, or on the part of the County Commissioners each shall notify the other party of such dissatisfaction and if the dissatisfaction cannot be removed and all parties fully satisfied, said agent shall be promptly removed. If an agent is removed by agreement between the parties, another competent and satisfactory agent shall be selected to continue the work to the completion of the contract in the same manner as originally provided.
