And, it is further, agreed that, should the above proposal, for the said work, be accepted by the Board of County Commissioners of Tulsa County, Oklahoma, and should the undersigned fail to enter into a contract of the form and terms provided, within ten (10) days after written notice has been given the undersigned of the awarding of the said contract, by the County Clerk of Tulsa County, Oklahoma, then and in that case, the certified check accompanying this proposal shall be cashed by the County Clerk of Tulsa County, as liquidated damages for the failure of the undersigned to comply with the terms of his or their proposal.
