per cent of all said delinquent or unpaid personal tax collected through the auspices of said Second Party, and said First Party does by these presents, assign, set over and convey unto said second party the aforesaid commission of fifteen per cent (15%) of all such delinquent and unpaid personal tax, as may be so collected.

IT IS FURTHER UNDERSTOOD AND AGREED that the aforesaid fifteen per cent (15%) commission is due and payable for the tax collected for each month at the close of said month.

IT IS FURTHER UNDERSTOOD AND AGREEDK that said First Party employ and retain said second party as their true, sole and lawful agent in these premises for the purpose of enforcing collection of said unpaid tax, and that this contract for this particular service is to be in full force and effect for a period of two (2) years from and after July 1st. 1925, unless for good cause same is rescinded by action of the First Party after due notice to said party, and a hearing before the Board of County Commissioners of Tulsa County.
