R E S O L U T I O N

WHEREAS, in pursuance of a Resolution passed and approved this 11th day of August, 1937, complete plans and specifications for the construction of One (1) sanitary rest room at the Tulsa County Fair grounds have been filed with the County Clerk of Tulsa County; and

WHEREAS, the Directors of the Agricultural and Industrial Exposition and Fair have requested that contracts be let covering the same, and

WHEREAS, the Board of County Commissioners has authorized and directed that the plans and specifications hereinbefore mentioned do not consider the price of the metal doors which are to be used in the construction and completion of the aforesaid mentioned rest room and that bids on the aforesaid mentioned rest room do not take into consideration the total bid as far as concerns these metal doors;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, in recessed meeting that the County Clerk of said County be, and he is hereby authorized and directed, with the assistance of the County Attorney, to give public notice of the letting of said contracts, with the restrictions hereinbefore set out and provided for in the plans and specifications, as required by law, and the County Clerk of said County be, and he is hereby directed to keep on file in his office the plans and specifications hereinbefore referred to for public inspection during the period of time covered by legal notice for same.

NOTICE TO CONTRACTORS.
