Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the Plans be accepted on Project 3-G, Proposal for the Improvement of East River Road from Sheridan Road to Jenks Bridge Connection - a distance of 4.3 Miles in Tulsa County, Oklahoma, and that the County Clerk be, and he is hereby ordered to publish notice to Contractors that sealed bids will be received in the office of the County Clerk until 9:00 O'clock A. M., Monday, May 3, 1948.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the appointment of W. A. Prince as Deputy Sheriff, effective April 19, 1948, at a salary of \$200.00 per month, vacancy created by the resignation of Chas. Page Campbell, be and the same is hereby approved.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the six Petitions concerning the modernization of the methods now in use, and requesting sufficient funds for the modernization and improvement of the operational methods of the offices of the County Assessor and County Treasurer, be and the same are hereby accepted and filed.

M. Said roads being located in Section 17, Township 19 N, Range 13-E, Tulsa County, Oklahoma.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried that Petition and Bond be accepted, and that the following Order be, and the same is hereby adopted:
