inclusive, Oklahoma Statutes, 1931, and any and all other statutes of the State of Oklahoma, covering the subject matter of this resolution, and the employ of tax ferret and his duties pertaining to such employment.

BE IT FURTHER RESOLVED, that this contract be and remain in force for a period of two years from the date hereof, and as long thereafter as may be mutually agreed upon between the Board of County Commissioners of Tulsa County and the said C. E. Marshall.

BE IT FURTHER RESOLVED, that the compensation of the said C. E. Marshall, as tax ferret, be and the same is hereby fixed at fifteen per cent of any and all sums recovered by him as taxes on omitted property and actually paid to and received from the County Treasurer of Tulsa County. All claims for services rendered and compensation under this contract shall be presented to the Board of County Commissioners for allowance.

BE IT FURTHER RESOLVED that a copy of this Resolution signed by the Board of County Commissioners and by the said C. E. Marshall shall constitute the contract of the employ as tax ferret.
