R E S O L U T I O N.

At a regular meeting of the Board of County Commissioners of Tulsa County, Oklahoma, held on the 19th. day of February, 1923, the following Resolution was introduced by F.M.Wooden, who moved its adoption, the same being seconded by Ira Short, and a vote being taken upon the same, was duly carried.

BE IT RESOLVED by the Board of County Commissioners of Tulsa County: That it is in their opinion to the best interest of Tulsa County that the drainage ditch at the East end of the Arkansas River Bridge at Jenks, Oklahoma, be repaired by driving pile, building wall, and otherwise improving same; and

IT IS FURTHER RESOLVED by the Board of County Commissioners that the work of repairing same be done and performed by A.C.Bancroft at actual cost thereof plus 15%, the total cost thereof not to exceed Nine Hundred (\$900.00) under the direction and subject to the approval of the County Engineer.

Motion was made by F.M.Wooden, seconded by Ira Short, that the Application of Phil J.Kramer, on an alleged erroneous tax assessment be and the same is hereby referred to Hon. Jas. Harrington and Hon. Ed O.Cassidy for opinion. Motion carried.
