Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the following Resolution be, and the same is hereby adopted:

RESOLUTION OF BOARD OF COUNTY COMMISSIONERS
VACATING ALLEY-WAY IN TULSA COUNTY, OKLAHOMA

Now on this the 19th day of April, 1948, there comes on for hearing before the Board of County Commissioners of Tulsa County, State of Oklahoma, the petition of resident free-holders of Second Lake Subdivision in Tulsa County, Oklahoma, which petition prays that this Commission vacate and set aside the dedication of an alley-way made by Chas Page on the 14th day of September, 1922, by Deed of Dedication, which deed is recorded in the Office of the County Clerk of Tulsa County, Oklahoma, in so far as said dedication includes the alley-way described as follows, to-wit:

An alley-way approximately 438 feet long and 16 feet wide, lying to the South and East of Lots One (1) to Ten (10) inclusive, of Block Four (4); and to the North and West of Lots Fourteen (14), Fifteen (15), Sixteen (16) and Seventeen (17) of Block Four (4), all in Second Lake Sub-Division, Tulsa County, Oklahoma, such alley-way lying between said Lots One (1) to Ten (10), inclusive, of said Block Four (4), and said Lots Fourteen (14) to Seventeen (17), inclusive of said Block Four (4).

And it appearing that said petition is in all respects sufficient and that due legal notice to the public for twenty (20) days by advertisement in the Tulsa Daily Legal News published in Tulsa, Tulsa County, Oklahoma, the official county paper, has been given, setting forth the facts and the date when this hearing was to be held and the petition acted upon, as shown by the return of the publisher of the said Tulsa Daily Legal News, attached hereto, marked "Exhibit A".

The petitioners appearing by their counsel of record and Tulsa County, Oklahoma, appearing by Hugh Webster, Assistant County Attorney, and George O. Straughan, County Engineer, appearing as a representative for all interests involved and the Commission being fully advised in the premises and there being no objections filed to said petition, finds that said plot or parcel of land so dedicated as an alley-way had never been used by the public as an alley and that an alley-way thereon is wholly unnecessary; that it has been enclosed by the adjacent lot owners ever since the said sub-division was platted and dedicated; that such alley-way is impractical and serves no necessary purposes whatsoever.

This Commission further finds that the above described plot of land is outside the limits of the City of Tulsa, Oklahoma, or any other incorporated City in Tulsa County, Oklahoma, and is not a part of any plat or addition to the City of Tulsa, Oklahoma, or any other city in Tulsa County, Oklahoma.

Be it Resolved by the Board of County Commissioners of the County of Tulsa, State of Oklahoma, sitting in regular session, that the dedication of the alley-way above described, in Block Four (4), Second Lake Sub-Division, Tulsa County, Oklahoma, be vacated and set aside, all as prayed for in said petition.
