And, the County Commissioners agree to pay further the following amounts to apply on the expense, equipment and maintenance of County Agents' work as carried on innthis County for the fiscal year beginning July 1st. 1925; Eighteen Hundred (\$1800.00)

Dollars for Stenographic help; Twelve Hundred (\$1200.) Dollars for expense of County Hundred

Farm Demonstration Agent; and Eight/ (\$\$800.00) Dollars for expense of the County

Home Demonstration Agent.

The Extension Division of Oklahoma Agricultural and Mechanical College, cooperating with the U S Department of Agriculture, shall select the agents and shall pay one hundred Ten (\$110.00) Dollars per month on the salary of the Farm Demonstration Agent; and One Hundred Ten (\$110.00) Dollars per month on the salary of the Home Demonstration Agent; furnish them with the franking privilege, stationery, literature and instructions. The Extension Division shall superintend the work of the agents; and pay their expenses when duly authorized to make trips outside of the County on official business.

It is hereby further agreed between the Extension Division of the Oklahoma Agricultural and Mechanical College and the County Commissioners of Tulsa County that in the event of any change in the personnel of the County or Home Demonstration Agents the County Commissioners will have the right to approve such change and to approve the agents who may succeed the present incumbents before such change is made.

The Agents' salaries shall be payable on or after the first of each month on certificate from the Extension Division of the Oklahoma A & M College that the work has been duly performed.

This agreement shall be in force for twelve (12) months beginning July 1st. 1925.
