County so deeded to, and held by, the County; and the County Clerk is hereby directed to certify a copy of this resolution to the Judge of the District Court of the said Tulsa County, with the prayer that said Judge determine that such sale is for the best interest of said County and order and direct this Board to sell said real estate as provided by law and appoint three disinterested freeholders of said County to appraise said real estate and make return of such appraisement of this Board.
