The Board of County Commissioners of the County of Tulsa, State of Oklahoma, met pursuant to adjournment with the following members present. F. M. Wooden, Chairman, W. L. North, Vice Chairman, Ed Dalton, member and Lewis Cline, County Clerk and Ex Officio, Secretary of the Board.

The following proceedings were had:-

The Bond of A. C. Bancroft, Contractor, for the construction of one bridge 18 ft. span, 24 ft. roadway, on Mile five (5) section "E", Tulsa County State Highway, and one bridge 20 ft. span, 20 ft. roadway, between sections two (2) and three (3) Township Nineteen (19) North, Range Thirteen (13) east, was filed with and approved by the Board of County Commissioners.

On motion of W. L. North, which motion was duly seconded by F. M. Wooden the bid of A. C. Bancroft for the culvert and bridge construction on Section "W1" Tulsa County, State Highway was accepted. Motion carried.

A motion was made by W. L. North and seconded by Frank M. Wooden that the proposal of Burke-Gibbs Company of Tulsa, Oklahoma for the grading, paving and otherwise improving according to the plans, specifications, etc., of the road set out in the published notice under date of October 22nd, 1920, being that part of the State Highway between the Arkansas River Bridge near Bixby to a connection with the paving in the town of Bixby, Oklahoma, be accepted. Said contractor to file contract and bond for the faithful performance of the work covered in said bid.
