in lawful money of the United States of America at County Treasurer's Office in the City of Tulsa, in the State of Oklahoma.

This Bond is one of a Series of Fifty Bonds, of similar nature, for One Thousand Dollars (\$1,000.00) each, and all issued by the Board of County Commissioners of said County of Tulsa, for the purpose of paying the balance of said Drainage District's share of the Cost and Expense of constructing and completing a system of levees, drains, ditches, and other improvements in Tulsa County Drainage District No. 12, of Tulsa County, acting in co-operation with the War Department of the United States of America, and as alleged in the Petition and Amendment herein, and in anticipation of the collection of the installments of Special Assessments duly levied upon lands and other property privately owned and subject to assessment within said District and benefitted by said improvements, in compliance with Chapter 30, of the Session Laws of Oklahoma for the year 1907-08, as amended from time to time, and now embodied in OKLAHOMA STATE DRAINAGE ACT, Chapter 3, Title 82 of 1941 Oklahoma Statutes, and pursuant to orders and resolutions of the Board of County Commissioners of Tulsa County, duly made and entered of record.

This Bond is based upon and constitutes a lien upon and is payable solely out of the proceeds of the special assessment for benefits theretofore legally levied on lands provately owned, and property of public service corporations, benefits and to be benefitted, and out of no other fund whatsoever. And it is hereby certified and recited that all acts conditions and things required to be done in creating, locating and establishing said drainage district, and in making and levying said assessment against lands and public service corporations benefitted thereby, and in the authorization, execution and issuance of this bond were and have been legally had, done and performed; that the total amount of bonds issued on account of said drainage district does not exceed the assessment so levied therefor and unpaid at the time said bonds are issued or any legal limitations thereof, and for the performance of all the covenants and stipulations of this bond and of the duties imposed by law upon the County of Tulsa for the collection of the principal and interest of said assessment and the application thereof to the payment of this bond and the interest thereon, and for the levying of such other and further assessments as are authorized by law and may be required for the prompt payment of this bond and the interest thereon the full faith, credit and resources of said County are hereby irrevocably pledged.

In testimony whereof, the Board of County Commissioners of said Tulsa County, in the State of Oklahoma, have caused this bond to be signed by their Chairman, countersigned and registered by the County Clerk with the seal of the county affixed, and the coupons hereto attached to be signed by the County Clerk as of this day June 1st A.D. 1944.
