has been filed with the County Clerk of Tulsa County, Oklahoma and this Board, and

WHEREAS, the said petition has been set for hearing by the County Clerk before this Board upon this 20th. day of July, 1925, and due and timely notice published as required by law, and

WHEREAS, No protests have been filed against the establishment of said District and against the boundaries thereof as above set out, and

WHEREAS, This Board has examined the said petition and has made an inquiry into the facts and into the necessity and advisability of the creation of said water improvement district and of the property that should be included therein.

IT IS THEREFORE FOUND by the Board that said petition is a good and sufficient petition and strictly conforms to the law, and that said Petition is signed by a majority of the holders of title to land within said proposed district whether numbers computed according to the number of the owners or according to acreage, and that said Petition was accompanied by a map of the proposed District showing its boundaries and the source of water supply and the approximate proposed location of the main distributing line, and accompanied also by good and sufficient bond as required by law, and that said hearing has been duly advertised as required by law and that the formation of said District will be conducive to the public health and welfare of said proposed district and that the plan of said amended district should not be changed by excluding from within its boundaries any lands not included therein in said petition and map or by including other lands; and that there is no incorporated town within the boundaries of said proposed District.

NOW, THEREFORE, BE IT RESOLVED, By this Board that the formation of the said District with boundaries as above described will be conducive to the public health and welfare of the said proposed district, and

BE IT FURTHER RESOLVED AND ORDERED, That an election of the qualified electors of the territory, included within the boundaries above described be and the same is hereby called to be held upon the 11th. day of August, 1925. The said election to be held at the regular voting precincts in which any of the land included in said proposed district is situated.
