The maximum speed of any other motor truck or other heavy vehicle using this bridge is limited to six (6) miles per hour.

No automobile shall travel over this bridge at a speed greater than ten (10) miles per hour.

The above order is for the regulation of the use of the Sand Springs-Arkansas River Bridge, and is hereby approved by the Board of County Commissioners of Tulsa County, Oklahoma, this the 26th. day of February, 1923, and the County Engineer is hereby directed to cause to be erected or posted, a suitable "Danger Notice" at each end of the said bridge, setting out the above order.
