

R E S O L U T I O N

BE IT RESOLVED, By the Board of County Commissioners of Tulsa County, Oklahoma, in adjourned regular session held on the 19th. day of December, 1927, that JOE T PARKINSON be and he is hereby employed to collect delinquent personal taxes in and for said County as provided by Section One of Chapter 36 of the Acts of the Tenth Legislature of the State of Oklahoma.

BE IT FURTHER RESOLVED, That the term of employment of said JOE T PARKINSON shall be from January 10th. 1928 to April 1st. 1929, and that said JOE T PARKINSON shall qualify by taking the constitutional oath of office and filing a bond in the sum of \$5,000. with a Surety Company authorized to do business in the state as Surety and said bond to be conditioned as provided by said Section One of said Chapter 36 of the Acts of the Tenth Legislature.

AND, BE IT FURTHER RESOLVED, that the remuneration of said JOE T PARKINSON shall be as follows:

Ten per centum on the amount of taxes, penalties collected on all items in excess of \$20.00 and twenty per centum on all items of \$20.00, or less, provided that the total fee for any one person, firm or corporation in any one year shall not exceed the sum of \$500.00

AND BE IT FURTHER RESOLVED, that upon the acceptance in writing of the terms and conditions of this resolution, by said JOE T PARKINSON the same shall be and constitute a contract of employment between the Board of County Commissioners of Tulsa County, Oklahoma, and said JOE T PARKINSON.

In the matter of the petition of the Oklahoma Natural Gas Corporation for permission to lay pipe lines, the following order was made:

O R D E R

NOW, On this the 19th. day of December 1927, the matter of the petition of Oklahoma Natural Gas Corporation for permission to lay a pipe line, under, through and across certain highways in said County and State came up before the Board of County Commissioners for hearing, and it appearing to the Board and each of the Commissioners thereof that it was just that the said Oklahoma Natural Gas Corporation be permitted to use as much of the highways as designated by plat filed by said corporation, and according to said description, which is as follows, to-wit:

Beginning at a point near the NW Corner of the intersection of Independence Street and North Lewis Ave., Tulsa, Oklahoma and running thence North along the west side of said North Lewis Ave. approximately six feet East of the West Line of said Ave. to a point near the NW corner of the intersection of New Lewis Ave. and Pine St., as indicated in yellow on the blue print map hereto attached and made a part hereof. This line to be known as "Service Lines - City of Tulsa", a proposed seven inch gas pipe line.

AND, it further appearing from the petition herein that said pipe line will be constructed as not to interfere with any of the rights of the general public in the use of the said highways; and will be constructed in accordance with all rules of the County Commissioners and the laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED, By the Board of County Commissioners of said County that permission be granted, and the same is hereby granted to Oklahoma Natural Gas Corporation, its successors and assigns, to use as much of the highways as above designated.
