Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that the Report of the Census taken in the Town of Dawson, Oklahoma, be and the same is hereby accepted, and that the following Order be, and the same is hereby approved:

O R D E R

This matter coming on for hearing upon an application to certify the results of the census taken in the Town of Dawson, Oklahoma; petitioners appearing by their attorneys, Gilmer & Kennon, and there being no objections thereto made or filed, the Board being fully advised in the premises, finds:

That on the 15th day of March, 1948, Mrs. A. D. Smith, Mrs. Ferrin Holcomb, Mrs. Julian Joseph, Mrs. H. V. Kappel, Mrs. Bruce Havens, and Mrs. Rex Maderia, all of Dawson, Oklahoma, were duly appointed census takers for the Town of Dawson, Oklahoma; that said census takers have agreed, and do agree, to waive any and all compensation for their work as such census takers; that a bond in the amount of \$500.00 was posted indemnifying the Town of Dawson, Oklahoma from any cost in connection with the taking of said census; that the census for the town of Dawson, Oklahoma was taken without cost to the town of Dawson, Oklahoma; that the result of the census of said town of Dawson, Oklahoma taken between the 15th day of March, 1948 and the 17th day of April, 1948, and that said records which were appended to the certification of the census takers is a true and correct census of the town of Dawson, Oklahoma, said census reflecting that Dawson, Oklahoma has a population of 2,743 people.

IT IS THEREFORE ORDERED that the result of the census takers of Dawson, Oklahoma shall be spread of record by the Board of County Commissioners of Tulsa County, Oklahoma, and filed with the County Clerk of Tulsa County as a permanent record, and a certificate thereof filed in the office of the Secretary of State for the State of Oklahoma, all provided by law.

IT IS FURTHER ORDERED that the bond in the amount of \$500.00 heretofore posted for the taking of said census without cost to the town of Dawson, Oklahoma, be, and it is hereby released and discharged.
