

3. That said petition showed that the petitioners requested the relocation of the road following the section line between Section 32, Township 19 North, Range 13 East, and Section 5, Township 18 North, Range 13 East, so that it would follow the line described as follows:

A strip of land 50 feet in width, in Tulsa County, Oklahoma, whose center line is described as follows:

Beginning at a point in the south line of Section 32, Township 19 N., Range 13 E., 25 feet west of the southeast corner of said Section 32; thence northwesterly along a circular curve having a radius of 500.5 feet, whose initial tangent is the south line of said section, a distance of 549.42 feet; thence N. 27° W. 155.78 feet; thence along a circular curve to the left having a radius of 500.5 feet a distance of 549.85 feet; thence west 1326.39 feet; thence along a curve to the left of radius 500.5 feet a distance of 549.27 feet; thence south 27° W. 155.23 feet; thence along a curve to the right of radius 500.5 feet a distance of 549.42 feet to a point in the south line of said Section 32, 3276.1 feet, more or less, west of the southeast corner of said Section 32.

Granted to Tulsa County for the purpose of maintaining a county road upon the above described property.

4. That on September 3rd the Honorable Board of County Commissioners after an investigation found that such a relocation was necessary and practical, and, therefore, ordered that due legal notice to the public be given for twenty days by advertisement in the West Tulsa News, setting forth the facts in the petition and that a hearing would be had thereon on September 30, and the petition acted upon.

5. That a record of all the proceedings herein have been made by the County Clerk.

It is therefore ordered, adjudged and decreed that the County road following the section line between Section 32, Township 19 North, Range 13 East and Section 5, Township 18 North, Range 13 East is hereby relocated to follow a line described as follows:

A strip of land 50 feet in width, in Tulsa County, Oklahoma, whose center line is described as follows:

Beginning at a point in the south line of Section 32, Township 19 North, Range 13, E., 25 feet west of the Southeast corner of said Section 32; thence northwesterly along a circular curve having a radius of 500.5 feet, whose initial tangent is the south line of said section, a distance of 549.42 feet; thence N. 27° W. 155.78 feet; thence along a circular curve to the left having a radius of 500.5 feet a distance of 549.85 feet; thence west 1326.39 feet; thence along a curve to the left of radius 500.5 feet a distance of 549.27 feet; thence south 27° W. 155.23 feet; thence along a curve to the right of radius 500.5 feet a distance of 549.42 feet to a point in the south line of said Section 32, 3276.1 feet, more or less, west of the southeast corner of said Section 32.

Granted to Tulsa County for the purpose of maintaining a County road upon the above described property,

That such relocation shall take effect immediately and that hereafter such relocated road shall be the official county road, instead of the section line as heretofore.

It is further ordered, adjudged and decreed that said Warren W. Lepley is hereby released from any obligation under his bond executed in favor of the County Commissioners herein, upon the finding of this Honorable Board that all costs herein have been paid in full.
