## CONTRACT

STATE OF OKLAHOMA, TULSA COUNTY,

THIS AGREEMENT, made this 5 day of June, 1944, between TULSA COUNTY DRAINAGE DISTRICT NUMBER 12, hereinafter called the Party of the First Part, and J. W. McMichael, J. O. McMichael and J. D. McMichael, doing business as McMichael Concrete Company, a Co-partnership of Tulsa, Oklahoma, Party of the Second Part, hereinafter called the Contractor, Witnesseth:

That the Contractor for and in consideration of the payment, or payments hereinafter specified and agreed to by the Party of the First Part, hereby covenants and agrees to furnish and deliver all material and to perform all the work and labor
