The construction of said highline to be subject to the approval and to be prected under the supervision of the County Enginner of Tulsa County, Oklahoma, and any change or re-location to be also subject to the supervision of the County Enginner of Tulsa County Engineer of Tulsa County, Oklahoma, Sand Springs Home agreeing at all times to hold Tulsa County harmless from liability to third persons arising from any negligence in the construction and maintenance and operation of said poles, wires and apparatus.
