BE IT FURTHER RESOLVED: That said deed be, and it hereby is, accepted by Tulsa County, Oklahoma, and that said county become bound and obligated to performance of all the provisions and conditions in said deed contained.

BE IT FURTHER RESOLVED: That an emergency exists and is hereby declared to exist, on account of which, this resolution shall take effect and be in full force from and after its passage.
