Motion made by Commissioner Couch, seconded by Commissioner Bailey, and un-animously carried, that the temporary appointment of W. H. Wards as a Deputy in the office of the Court Clerk at a salary of \$200.00 per month, effective as of May 1, 1950, be, and the same is hereby approved.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and un-animously carried, that the following Resolution be, and the same is hereby adopted:

R E S O L U T I O N

WHEREAS, the United States of America desires to lease from Tulsa County a tract of land owned by the County, as a site for the construction of Organized Reserve Corps Armory and other governmental purposes; and

WHEREAS, the Adjutant General of the State of Oklahoma, as Trustee for the Oklahoma National Guard, desires by way of supplemental agreement, to amend its lease of 6 May, 1946, relinquishing said tract of land in order that it may be leased to the United States of America for the construction of Organized Reserve Corps Armory and other governmental purposes; and

WHEREAS, said tract of land is not needed for county purposes, and it is deemed advisable and to the best interests of the county and its residents, that said land be leased as aforesaid, and that the lease to the Oklahoma National Guard be amended as aforesaid;

NOW, THEREFORE, BE IT RESOLVED that the Chairman be, and he is hereby authorized and directed to execute a lease substantially as follows:

" 1. THIS LEASE, made and entered into this _____ day of _____ in the year one thousand nine hundred and fifty by and between The Board of County Commissioners of Tulsa County, State of Oklahoma whose address is Tulsa, Oklahoma and whose interest in the property hereinafter described is that of owner for itself, its successors, and assigns, hereinafter called Lessor, and THE UNITED STATES OF AMERICA, hereinafter called the Government:

" WITNESSETH: The parties hereto for the considerations hereinafter mentioned covenant and agree as follows:

" 2. The Lessor hereby leases to the Government the following described premises, viz:

A tract or parcel of land located in the South Half of Section 9, Township 19 North, Range 13 East, Tulsa County, Oklahoma, particularly described as follows: Beginning at the center of Section 9, Township 19 North, Range 13 East, located in the center of East 15th Street, run thence East 66 feet to a point; thence South 600 feet to a point; run thence West 290.4 feet to a point; run thence North 600 feet to a point in the center of East 15th Street; run thence East along the center of East 15th Street 224.4 feet to the point of beginning, containing 4 acres, more or less,

to be used for the following purposes: Site for construction of Organized Reserve Corps Armory and other Governmental purposes.
