The Board of County Commissioners of Tulsa County, Oklahoma, met in regular session, at 10:00 o'clock A. M. All members present.

Upon motion, Board adjourned to meet at 1:30 P. M.

The Board of County Commissioners met in their rooms, at 1:30 o'clock P. M., in regular session.

Order establishing Drain No.2 Moved by Mr. North and seconded by Mr. Woolley that report of viewers on Drain or Improvement District No.2, be appointed and the **Drainage District** established, as per report on file in the office of the County Clerk. Motion prevailed.

Order setting date for receiving bids Drain No.2. Moved by Mr. Woolley and seconded by Mr. North, that December 24, 1912, be set as the day for receiving bids and letting contract for constructing Drain or Improvement District No. 2, and setting December 24, 1912, as the limit for payment of assessments for said Drain or Improvement District No. 2, and that the County Clerk be instructed to give notice thereof. Motion prevailed.

Moved by Mr. North and seconded by Mr. Woolley that Mr. R. K. Hughes be appointed Engineer or Surveyor for Drain or Improvement District No. 2. Motion prevailed.

Moved by Mr. North, that the County Treasurer be instructed to pay location costs of Drain or Improvement District No.2, out of the Sinking Fund and to deduct same from the first money derived from assessments upon said Drainage District. Motion seconded by Mr. Woolley. Motion prevailed.

Order establishing Tel.line along Public highway Upon motion of Mr. Woolley, seconded by Mr. North, the petition of Ralsa F. Morley and others for constructing and maintaining a Telephone line along certain public highway of Tulsa County, was approved as per petition on file in the office of the County Clerk. Description of line being as follows:

Beginning at a point at Kendall College and attached onto the Pioneer Telephone & Telegraph Company's wires and extending east on South side of the highway between Sections Five (5) and Eight (8) to the juncture of said Sections, with Sections Four (4) and Nine (9), thence turning at right angle and running South on the west side of the highway for Four & one-half (4½) miles between the following Sections: Sections Eight (8) and Nine (9); Sexteen (16) and Seventeen (17); Twenty (20) and Twenty-one (21); Twenty-eight (28) and Twenty-nine (29) and Sections Thirty-two (32) and Thirty-three (23) to the middle of said last sections. All of said highway being in Township Nineteen (19), Range Thirteen (13) East, in Tulsa County, State of Oklahoma.
