FROM NORTHERLY BOUNDARY LINE OF SAID CITY TO
SOUTHERLY BOUNDARY LINE OF OSAGE COUNTY AS FARM—
TO-MARKET-ROAD

WHEREAS, The Chamber of Commerce of Sand Springs, Oklahoma, and other resident and free-holders thereof have requested the road hereinafter described be set aside and designated as a farm-to-market-road, which will be to the advantage of farmers in that vicinity in marketing their live-stock and produce as well as residents of the City of Sand Springs, and

WHEREAS, said roadhas heretofore been developed and improved by Tulsa County, Oklahoma.

NOW THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Tulsa County, State of Oklahoma, sitting in a regular session, that the improved County road, which is a prolongation of North McKinley Avenue of the City of Sand Springs extending from the Northern boundary line of the City of Sand Springs in a Northerly direction to the Southerly boundary line of Osage County be, and same is hereby designated and set aside as a farm-to-market-road, within the purview and meaning of the rules and regulations of the State of Oklahoma applicable thereto.
