PROCLAMATION AND NOTICE OF ELECTION

NOTICE IS HEREBY GIVEN that under and by virtue of Section 26, Article 10 of the Constitution of the State of Oklahoma and Title 19, Chapter 17, Oklahoma Statutes 1941 and laws supplementary and amendatory thereto, and a resolution duly adopted by the Board of County Commissioners of Tulsa County, State of Oklahoma on the 21st day of October, 1946, an election will be held in said county on the 26th day of November, 1946 for the purpose of submitting to the qualified electors of said county the following proposition:

"Shall the County of Tulsa, State of Oklahoma, by its Board of County Commissioners, incur an indebtedness by issuing its negotiable coupon bonds in the sum of One Million Two Hundred Fifty Thousand (\$1,250,000.00) Dollars to provide funds for the purpose of purchasing a site for, erecting and constructing a county hospital to be owned exclusively by said county and levy and collect an annual tax, in addition to all other taxes, on all the taxable property in said county sufficient to pay the interest on said bonds as it falls due and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to bear interest at not to exceed three per centum per annum, payable semi-annually and to become due serially within twenty five years from their date?"

The ballots used at said election shall be printed and shall set out the proposition substantially as set forth above and shall also contain the words:

First: For bonds.

SECOND: Against Bonds.

(An elector desiring to vote for the bonds shall stamp or mark an "X" in the first square above; if he desired to vote against the bonds he shall stamp or mark an "X" in the second square above).
