These cases were denied Office Medium from Agricultural by Tulsa Metropolitan Area Planning Commission (TMAPC) 10/19/05. Dane Matthews, INCOG, explained the vote to deny this application by the TMAPC. John Moody, attorney for the applicants, spoke of the reason for the changes, and explained the amendment sent to Owasso Planning Commission on Friday, 12/16/05, had been withdrawn. Mr. Moody introduced the plan from the website which showed several commercial developments in the making, and stated this would happen in the future, and his clients will be affected. They are asking for fair treatment in this matter. Kevin Coutant, attorney representing Frosty Turpen and Rick Roberts, homeowners from the area, requested the area remain residential and explained the other properties around them are zoned residential and agricultural. He also stated there would be no legal substance for assurance of an office park. Commissioner Collins asked about an annexation and the legal impact for the City of Owasso. Eric Wiles, Community Development Director for Owasso, introduced the Owasso Master Plan and its concepts, showing

Highway 169 and arterial development with commercial use at intersections adopted in 2004 and how the approval of the appeals would disrupt this master plan. It showed the highest and best use of the properties in questions would be residential.

Commissioner Dick asked when the comprehensive plan was adopted and have there been exceptions. Mr. Wiles advised the plan was adopted in September, 2004, and there have been some exceptions. Brent Culgan, Owasso City Council, advised the concern from the homeowners about traffic due to a new hotel and several other commercial properties. If the appeal is passed this will bring more traffic further east on 96th Street North and will not be productive to the master plan.

Commissioner Miller asked if there were other homeowners present which opposed the rezoning and a few raised their hand. Rodney Ray, City Manager for Owasso, advised Owasso is one of the fastest growing cities in Oklahoma and has worked hard to overcome problems other cities have faced. He would like to see this area developed to the master plan, and requested the Commissioners deny the appeal.

Frosty Turpen, homeowner, requested the properties remain residential and Jim Ponton, homeowner, seconded the request to remain residential and advised that there is a signed petition by several other homeowners in agreement, which the County Clerk has a copy on file.

Jack Ojala, property owner for 31 years, requested the re-zoning change and stated he is in total disagreement with the City of Owasso. He believes 96th Street North will be largely commercial and asked why the homeowners could not reap some of the benefit.

Rob Haskins, property owner, also requested the re-zoning, and also believes 96th Street North will be largely commercial. He moved in to his home in the year 2000 and when Walmart was developed, the traffic increased. The growth is moving up the highway. He stated they asked for the re-zoning to be on a level playing field in regard to their properties.

Steve Johnson, homeowner, stated 96th Street North is going to be a carrier street, and will have a substantial amount of traffic, and is the best access to Highway 169.

Kurk Ocobock, homeowner, presented pictures of the First Baptist Church and a copy of the church's study for development of approximately of 250,000 sq. ft. dated December, 2003 and suggested this was not appropriate for a buffer, as indicated. Also, 36 acres at the end of 136th Street is preparing for substantial commercial development as per Heavenly Hospitalities website.

Lynn Dobbs, homeowner, stated she has a contract on her home since June, 2005, with a stipulation for office use. She lives on 96th Street North and her family has had several car accidents due to the increased traffic.

Commissioner Collins acknowledged the appreciation of each speaker, and entertained a motion for approval or disapproval. Commissioner Dick advised he had driven the area but since the area involved is Commissioner Collins' district, Commissioner Collins should advise as to this request. Commissioner Collins advised Owasso is going through growing pains and believes change is inevitable, and agrees with the re-zoning change.

Commissioner Miller is of the opinion that this is a neighborhood being proactive, and this is a situation where office median zoning is complimentary with residential zoning instead of what commercial would be, and the residents have come up with a compromise to develop and pursue, with the City of Owasso.

Moved by Miller, seconded by Dick, to approve Applicants request for re-zoning of this property from agricultural to office medium. Upon roll call, Dick, yes; Miller, yes; Collins, yes. Motion carried.
