Motion was made by F.M.Wooden, seconded by Ira Short, that when the Excise Board meets that Mr. Gilmore, who is Chairman Board of Co.Commissioners, and also member of the Tulsa County Excise Board, be requested to make an especial effort to obtain for the use of the Tulsa County Public Health Association, an additional appropriation of \$2,000 for the carrying on of their work for the remainder of the Fiscal Year, ending June 30th. 1923. All members voting in the affirmative, same was declared carried.

Motion was made by F.M.Wooden, that Tax erroneously assessed against Sam'l A.Boorstein, by and through his attorney, L.Becker, be refunded for the years 1919-1920 and 1921, inasmuch as same was homestead of Creek-Freedman, Lena Morris, original allottee, until on or about Jan. 30, 1923. Motion was duly seconded by Ira Short, and declared carried.

At a meeting of the Board of County Commissioners of Tulsa County, Oklahoma, held in the office of said Commissioners in the Courthouse, in the City of Tulsa, on the 19th day of March, 1923, the following resolution was introduced by Commissioner F.M. Wooden, who moved its adoption, and said motion was seconded by Commissioner Ira Short, and the Resolution was ordered read:

RESOLUTION.

WHEREAS, it is necessary for the Board of County Commissioners to make application to the Excise Board of said County for additional and supplemental appropriation for current expenses purposes for the remainder of the fiscal year ending June 30th. 1923,

THEREFORE, BE IT RESOLVED, That the Honorable State Examiner and Inspector be, and he is hereby requested to prepare a Financial statement of the General Fund of said County, for the fiscal year ending June 30th. 1923, and as of March 31st. 1923, and if said statement shows an available surplus of revenue that an application be made to said Excise Board for additional and supplemental appropriations for the above named purposes.

The motion to adopt the Resolution was declared carried and the Resolution ordered made of record and a certified copy of the same ordered transmitted to Honorable Fred Parkinson. State Examiner and Inspector, Oklahoma City, Oklahoma.

The matter of selling certain real estate in the city of Jenks, as per advertisement of sealed bids asked for by Board of County Commissioners, was deferred until the next regular meeting. Motion was made by F.M.Wooden, that Bids be received and filed, and that final action will be taken at the next regular meeting of the Board. Motion was duly seconded by Ira Short, and declared carried.

Complaint has been made to this office, this day, by a citizen of this City and county to the effect that the jitney drivers operating a jitney line on Federal Drive east of the city limits of the City of Tulsa, at the place where they have their terminus station are monopolizing or obstructing the public highway, to the extent that it very greatly obstructs or hinders the public in the use of such highway.

It is the opinion of this office that this matter should be referred to your Board of or investigation and for the proper orders in the premises if it is necessary in your opinion to make any to be placed in the hands of the Sheriff for service and execution.
