Therefore, be it resolved by the Board of County Commissioners of Tulsa County, Oklahoma, that H.L.Standeven, of Tulsa Oklahoma be and he is hereby appointed County Judge of Tulsa County, Oklahoma to fill the vacancy in said office caused by the resignation of the aid John R. Ramsey.

He, the said H.L.Standeven, to hold said office of County Judge of Tulsa County Oklahoma until his successor is elected and qualified.
