Beginning at the Southeast corner of the Southeast Quarter of Section 12, Township 20 North, Range 14 East, thence East along the highway a distance of 80 rods.

AND, it further appearing from the Petition herein that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways, and will be constructed in accordance with all rules of the County Commissioners and the laws of the State of Oklahoma governing same.

IT IS, THEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of Tulsa County, Oklahoma, that permission be granted the said A E SMITH, his successors and assigns, to use as much of the highways as above designated.

In the matter of the Petitions of POSEY R SHORT, the following orders were made;

O R D E R.

Now, on this, the 7th. day of July, 1930, the matter of the Petition of Posey R. Short, for permission to lay a pipe line along, under and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearing and it appearing to the Board and each of the Commissioners thereof that it was just that the said Petitioner be permitted to use as much of the highways as designated by plat filed, and according to said description, which is as follows, to-wit:

Beginning at the North line of Township 18 North, Range 12 East, in Tulsa County, Oklahoma, upon the public highway between Sections One (1) and Two (2) in Township 18 North, Range 12 East; thence running South on the East side of said Highways, a distance of three (3) miles and across Section line to the NW corner of Section 24, Township 18 North, Range 12 East; thence East on the South side of the highway, or section line between Sections 13 and 24-18-12 a distance of one-half ($\frac{1}{2}$) Mile; thence South along the half mile Section line to the center of Section 24-18-12 a distance of $\frac{1}{2}$ mile; thence East along the half mile Section line in said Section 24 a distance of $\frac{1}{2}$ mile, to the Range Line between Section 24-18-12 and Section 19-18-13; thence East across said Range or Section line and along the North side of the highway upon the $\frac{1}{2}$ section line to the center of Section 19-18-13; as more fully shown on blue print hereto attached marked Exhibit "A", and made a part hereof. This line known as "Service Lines County of Tulsa" a proposed 2 inch gas pipe line.

AND, it further appearing from the petition herein that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways, and will be constructed in accordance with all rules of the County Commissioners and the laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said County that permission be granted, and the same is hereby granted to said Posey R Short, his successors and assigns to use as much of the highways as above designated.

NOW, ON this the 7th. day of July, 1930, the matter of the petition of ROSEY R SHORT, for permission to lay a pipe line along, under and across certain highways in said County and State, came up before the Board of County Commissioners of said County and State for hearing and it appearing to the Board and each of the Commissioners thereof that it was just that the said Petitioner be permitted to use as much of the highways as designated by plat filed, and according to said description, which is as follows, to-wit :

From a point at the SE corner of Lot 12, in Block 6, Easton Heights Addition to the City of Tulsa, Oklahoma, thence North along the West Side of 29th. West Avenue to the North line of Easton Court; thence West along the North side of said Easton Court to the West line of 33rd West Ave; thence South along the West side of said 33rd. West Ave. to the SW corner of 33rd West Ave and Easton St; thence West along the North side of said Easton St. to the East line of 34th West Ave; or the NW corner of Block 1 in Eagle Crest Add. to Tulsa, Oklahoma, thence South along the East side of 34th. West Ave. to a point in SW corner of Lot 6, Block 1, in Eagle Crest Add. to Tulsa, Oklahoma; also from the NW corner of 33rd West Ave. and Easton St. South along the West side of 33rd. West Ave., across Cameron St. to the South line of said Street, thence East along the south line of Cameron St. to the SW corner of 31st. West Ave. and Cameron Sts; thence South along the west side of 31st. West Ave. to a point in center of the East line of Lot 6 in Block 10 Easton Heights Add to Tulsa, Oklahoma; also from the NW corner of Easton Court and 31st. West Ave; thence South across Easton Court and along the West line of 31st. West Ave. to the NW corner of 31st. West Ave and Easton St; thence East across 31st. St. West Ave and along the North side of Easton Street to the SW corner of Lot 18 in
